1. Statement

Ipswich City Council will be a leader in environmental excellence by identifying, preventing, and managing any potential adverse environmental impacts associated with the delivery of its operations, activities, products, and services. Environmental best practice is an important objective for all our community, including those who work and do business in Ipswich, and for Council.

2. Purpose and Principles

This policy directs the Council's decision-making by prioritizing the protection of the environment, its inherent values, and ecosystem functions. It ensures compliance with regulatory obligations and fosters continuous improvement in environmental management to enhance the city's overall environmental performance.

The following principles underpin Council's commitment to environmental protection:

- Plan Do, Check, Act
- Understand Potential impacts of actions and activities
- Protect the environment by preventing or mitigating adverse environmental impacts
- Comply with all relevant environmental legal obligations
- Regulate Undertake its duties as a Regulatory Authority for development and land use activities in accordance with all relevant obligations and standards
- Manage environmental-related risk effectively and in a manner that is integrated with other risks across Council
- Continually improve the suitability, adequacy, and effectiveness of environmental management to enhance environmental condition outcomes and performance
- Encourage responsible environmental practice by all stakeholders across Ipswich
- Commit to best practice environmental incident control, rectification, and reporting
- Achieve environmental objectives
- Strive For better environmental compliance and environmental outcomes for development and land use across Ipswich beyond compliance

5. Human Rights Commitment

6. Scope

• This policy applies to all council staff, contractors, and others working on Council's behalf to ensure they work in accordance with the policy principles and in accordance with the relevant legislation.

- This policy applies to all of Council business or activities which have the potential to cause adverse environmental impact or influence functions including pollution, contamination, damage, biosecurity impacts, and issues affecting soil, air, water, land, flora, fauna and humans including cultural heritage, cultural landscapes and their interrelations.
- This policy applies to environmental protection within Council's legislative requirements and responsibilities. This policy does not apply to activities that are outside of Council's control.
- This policy does not apply to Federal or State matters e.g., investigation, management, regulations, licenses and permits which sit with the QLD Department of Environment, Tourism, Science, and Innovation.
